



The 2016 Change a Life Wonderland Cycle Tour is heading to the tropical island paradise of Mauritius from 22 to 27 September. 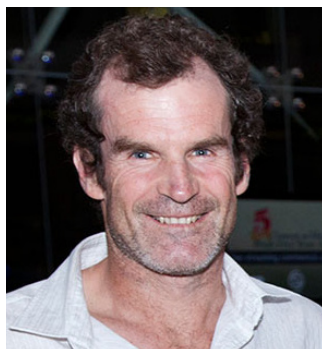
